MORPHOTRUST USA, LLC.

(hereinafter referred to as "MORPHOTRUST USA, LLC") having its principal place of business at 296 Concord Road, Suite 300 Billerica, MA 01821

WHEREAS, SBBC and L-1 Enrollment Services entered into an Agreement dated December 15, 2009 (hereinafter referred to as "Agreement"), under RFP 29-067N – Fingerprinting and Background Check Services for the purpose of providing fingerprinting and background check services; and

WHEREAS, On January 1, 2014, MORPHOTRUST was converted to a limited liability company on December 31, 2013 and MORPHOTRUST's corporate name was officially changed from MorphoTrust USA, Inc. to MorphoTrust USA, LLC. all references to "L-1" or "MORPHO" in the Second Amendment, First Amendment and original Agreement are changed to MORPHOTRUST USA, LLC.

WHEREAS, the Parties mutually desire to amend certain provisions of this Agreement.

WHEREAS, the Agreement was previously modified by a First Amendment to Agreement dated April 6, 2012 and Second Amendment to Agreement dated May 7, 2013.

- NOW, THEREFORE, in consideration of the premises and of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

SBBC authorizes SBBC's Chief of Police to approve the provision of such additional services up to a maximum of \$5,000 during the term of this Agreement and to pay for such additional services from the revenues derived by SBBC from the fees generated under this Agreement.

SBBC reserves the right to process applicants for issuance of identification badges, including, but not limited to, fingerprinting and photographing applicants that are covered under the provisions of this contract due to the following reasons:

- a) Transition time period for production of the uniform statewide identification badge by MORPHOTRUST USA, LLC during the 2013/2014 school year; and
- b) Exigent circumstances as determined by the sole judgment of SBBC's Chief of Police or his/her designee.
