FIFTH AMENDMENT TO EMPLOYMENT AGREEMENT

(hereinafter referred to as "VIGNOLA" or "DEPUTY GENERAL COUNSEL") whose principal place of business is 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301.

WITNESSETH:

WHEREAS, SBBC and VIGNOLA entered into an Employment Agreement, dated on or about October 7, 2008 (hereinafter "Employment Agreement"); and

WHEREAS, SBBC subsequently amended the Employment Agreement on September 1, 2009, September 21, 2010, October 18, 2011, and May 21, 2013; and

WHEREAS, the parties mutually desire to extend the term of employment for an additional year for as set forth herein.

NOW THEREFORE, in consideration of the premises and mutual agreements herein provided, SBBC and VIGNOLA hereby agree as follows:

1. **RECITALS**.

The foregoing recitals are true and correct and incorporated herein by reference.

2. **EMPLOYMENT AND TERM.**

The following should be added to paragraph 2 of the Employment Agreement:

SBBC hereby employs VIGNOLA as DEPUTY GENERAL COUNSEL, and VIGNOLA hereby accepts and agrees to such employment, for an additional year, commencing July 1, 2014 and ending June 30, 2015.

3. **COMPENSATION.**

The following should be added to paragraph 4(A):

The salary increase as provided to other 12-month administrative employees through Agenda Item GG-6 on June 9, 2014 shall be applicable to the DEPUTY GENERAL COUNSEL's salary, as set by prior amendments, and shall be effective January 1, 2014.

4. OTHER PROVISIONS IN EFFECT.

Except as expressly provided herein, all other portions of the Employment Agreement as amended remain in full force and effect.
