**TITLE:**  
Recommendation to Reject all Bids - 15-027B - Dental and Medical Supplies and Equipment

**REQUESTED ACTION:**  
Approve the recommendation to reject all bids for the above contract. It was determined that a revised format should be used in order to better meet the needs of the School Board. A new solicitation will be issued in August 2014, after the Board has approved this recommendation to reject all bids.

**SUMMARY EXPLANATION AND BACKGROUND:**  
The School Board of Broward County, Florida (SBBC), received four (4) bids for Bid 15-027B, Dental and Medical Supplies and Equipment. The bidders were: NM Enterprises of Plantation, Inc. D/B/A Medix USA, Inc.; School Kids Healthcare; Moore Medical LLC; and Palm Beach Dental Supply, Inc. (A copy of the complete bid is available for review in the Procurement and Warehousing Services Department).  
The District currently utilizes two (2) bids for medical and clinical supplies and equipment. Bid 13-023B expires August 31, 2017, and Bid 51-050B (State Contract) expires September 20, 2014. These contracts will be terminated once a new solicitation is in place.

**CONTINUATION OF SUMMARY EXPLANATION AND BACKGROUND**

No bid tabulation is being provided, per Florida State Statute 119.071.(b)(3), as follows:

“If an agency rejects all bids, proposals, or replies submitted in response to a competitive solicitation and the agency concurrently provides notice of its intent to reissue the competitive solicitation, the rejected bids, proposals, or replies remain exempt from s. 119.07(1) and s. 24(a), Art. 1 of the State Constitution until such time as the agency provides notice of an intended decision concerning the reissued competitive solicitation or until the agency withdraws the reissued competitive solicitation. A bid, proposal, or reply is not exempt for longer than 12 months after the initial agency notice rejecting all bids, proposals, or replies.”
