RESOLUTION IN SUPPORT OF NOVEMBER AS NATIONAL HOMELESS YOUTH AWARENESS MONTH

WHEREAS, on July 11, 2007, both the United States House of Representatives and the Senate passed a resolution declaring November, National Homeless Youth Awareness Month; and

WHEREAS, according to the National Coalition for the Homeless, 1.6 million teenagers in the United States are homeless on any given night with this population equally divided between male and female, between the ages of 15 and 17; and

WHEREAS, in Broward Schools alone, 2,300 students were identified as homeless in the 2013-2014 school year; and

WHEREAS, the future well-being of our schools and city depends on the value we place on our youth and in particular on our actions to provide these most vulnerable of our young people with opportunities to acquire the knowledge, skills and abilities they need to find and maintain stable housing and develop into healthy and productive adults; and

WHEREAS, District staff in partnership with numerous community agencies and organizations endeavor to remove barriers faced by homeless students, yet the number of effective programs providing services and support to homeless youth in Broward County are only a fraction of what is needed to fully address the needs of these young people; and

WHEREAS, the Broward Schools Homeless Education Assistance Resource Team empowers homeless students and families through educational advocacy and support while promoting awareness in schools and the community; and

WHEREAS, the School Board of Broward County recognizes that youth homelessness continues to be a serious problem for many students and families in Broward County; and

WHEREAS, the purpose of this resolution is to educate the public about the many reasons people, especially youth, are hungry and homeless; including the shortage of affordable housing in Broward County for very low income residents; and to encourage support for homeless assistance as well as community service opportunities for students and school service organizations.

RESOLUTION IN SUPPORT OF HOLOCAUST AWARENESS WEEK April 13 - 17, 2015 HOLOCAUST REMEMBRANCE DAY (Yom HaShoah) April 16, 2015

WHEREAS, prejudice, bigotry, racism and hate have been the cause of conflict, war and mass atrocities throughout history, and

WHEREAS, the Nazi regime was able to exploit severe economic hardships in the aftermath of World War I to foster prejudice and hatred toward a group that had historically been used as scapegoats throughout Europe, culminating in the attempt to exterminate the Jewish population in Europe, widely known as the Holocaust; and

WHEREAS, during the Holocaust, at least 11 million people were brutally murdered, at least 6 million of whom were Jewish people; and

WHEREAS, other marginalized groups, such as Soviet prisoners of war, ethnic Poles, children and adults with disabilities, homosexuals, intellectuals and political and religious dissenters were victims of the Holocaust; and

WHEREAS, it is imperative that we and future generations never forget the tragic lessons learned from the organized, government-sponsored mass killings of the Holocaust; and

WHEREAS, it is also important to remember, honor and emulate those righteous people who risked their lives to save thousands of innocent people during the Holocaust and to learn from their legacy of courage, selflessness and hope; and

WHEREAS, as a common standard of achievement for all people and nations, the Universal Declaration of Human Rights of 1948 (Declaration) adopted by the United Nations asserts that "recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world; and

WHEREAS, although in Broward County there were more than 700 children reunified and almost 200 children adopted last year, there remains a tremendous need for more families willing to provide foster care for or to adopt children; and

WHEREAS, during National Foster Care Month, we recognize the devotion, caring and selflessness of foster parents, faith-based and community organizations, advocacy groups, mentors, and tutors who strive to ensure that these children receive rich opportunities and the support they need to reach their full potential.

RESOLUTION IN SUPPORT OF FAMILY LIFE & HUMAN SEXUALITY EDUCATION MAY, 2015

WHEREAS, American youth are exhibiting behaviors leading to increasing rates of life-threatening or health-compromising sexually transmitted diseases that in part reflect ignorance of sexual health promoting behaviors; and

WHEREAS, youth infection with HIV/AIDS has reached an epidemic level, particularly among young gay men and ethnic minority youth, in part because of the lack of knowledge about protective behaviors; and

WHEREAS, children are becoming involved in sexual activities at younger ages; and

WHEREAS, over 1 million teenage women become pregnant annually and approximately 300,000 of these teenagers become homeless or runaways or both; and

WHEREAS, the prevalence of sexual intercourse appears to be higher among youth who did not receive sexuality education; and

WHEREAS, youth whose sexual orientation or whose values, beliefs and practices differ from those deemed acceptable by many in our society are subject to persistent, subtle or overt harassment and violence which may lead to suicide; and

WHEREAS, youth with a physical or mental disability may be more vulnerable to sexual coercion; and

WHEREAS, dating violence, sexual abuse and other forms of sexual violence are traumatic events that have become increasingly prevalent; and

WHEREAS, sexual health, personal self-esteem and the ability to participate in responsible, caring and stable relationships, as well as to develop positive interpersonal social attitudes can be promoted through education; and

WHEREAS, access to comprehensive sexual health education is critical to healthy development. Such information should be positive, age appropriate and culturally suitable and should respect the choice of abstinence; it should acknowledge women's rights, should foster shared responsibility among males and females for sexual behaviors and should promote tolerance for sexual diversity;
