Agreement between the Charter School and The School Board of Broward County, Florida, and to specify that any required hearing be			
conducted by the Division of Administrative Hearings under the procedures of Section 1002.33(8)(b)(2), Florida Statutes. SUMMARY EXPLANATION AND BACKGROUND:

The School Board of Broward County, Florida is requested to authorize the Superintendent to provide Broward Charter School of			
Science and Technology, Inc., (Broward Charter School of Science and Technology – 5055), written notice of the Sponsor's intent to terminate the Charter School Agreement in accordance with Section 1012.33(8)(b), Florida Statutes.			
terminate the Charter School Atgreement in accordance with Section 1012.33(0)(0), 1 fortula statutes.			
On March 20, 2012, Broward Charter School of Science and Technology, Inc., (Broward Charter School of Science and Technology –			
5055), entered in to a Charter School Agreement with The School Board of Broward County, Florida, that became effective July 1, 2012,			
and covers a term of five years commencing on July 1, 2012, and ending June 30, 2017.			
Pursuant to Section 1002.33(9)(n)(4), Florida Statutes, a Sponsor shall terminate a charter school agreement if the charter school earns			
two consecutive grades of "F." On July 11, 2014, The Florida Department of Education released school letter grades for the 2013-2014			
school year and, for the second consecutive year, Broward Charter School of Science and Technology – 5055, has received a state			
designated grade of "F". Broward Charter School of Science and Technology, Inc., may submit a request for a waiver of termination to			
the State under section 1002.33(9)(n)(4)(c), Florida Statutes.			
In addition to the mandatory term under state law, Section 2.D.1.a of the Charter School Agreement states that "Grounds for "Good			
Cause" for termination or non-renewal shall include, but not be limited to, the following: (2) receipt by the School or a State designated			
grade of "F" in any two (2) of four (4) years"			
An Executive Summary is attached along with a proposed notification letter, which states in reasonable detail the grounds for the			
intended termination. It is recommended that the School Board exercise its authority under Section 1002.33(8)(b)(2), Florida Statutes, to specify that any required hearing be conducted by the Division of Administrative Hearings.
