
This Second Amendment reconciles the variance of additional fees for design services and extended construction administration provided by the Project Consultant in the amount of \$67,777.27 with additional construction costs associated with change orders attributable to design errors and omissions in the amount of \$12,409.75 resulting in a net increase to professional fees totaling \$55,337.52 as set forth below:
