Photovoltaic for Schools Pilot Program Contract with Florida Power & Light (FPL) Driftwood Middle School

REQUESTED ACTION:

Approve the contract between The School Board of Broward County, Florida, and Florida Power & Light (FPL) for the Photovoltaic for Schools Pilot Program at Driftwood Middle School.

SUMMARY EXPLANATION AND BACKGROUND:

Florida Power & Light (FPL) will be donating a total of two (2) ten (10) KW photovoltaic systems (solar) over a five (5) year period. FPL has agreed to install a solar array at Driftwood Middle School. FPL will install, own, and maintain each solar system for a period of five (5) years from the in-service date, and will transfer ownership to The School Board of Broward County, Florida, at the end of the five (5) year period. FPL will provide teacher training and educational materials for each school where the system is installed. FPL will oversee design and construction by engineers and electrical contractors of each system. FPL will provide a five (5) year warranty on each installation.

This contract has been reviewed and approved as to form and legal content by the Office of the General Counsel.
