Transportation Agreements for City Recreation Programs

REQUESTED ACTION:

Approve agreements between The School Board of Broward County, Florida and the City of Fort Lauderdale, City of Miramar and City of Pompano Beach, to provide school bus transportation for recreational programs for the period of one year.

SUMMARY EXPLANATION AND BACKGROUND:

The transportation agreements allow the cities to utilize District school buses for city sponsored recreation programs and events that are dependent on transportation. City sponsored recreation programs provide a valuable service to their respective communities. Transportation services will be provided during the times school buses are not being utilized for service to Broward County Public Schools. The City of Fort Lauderdale, City of Miramar and City of Pompano Beach will reimburse the District for the full cost of this service at the approved reimbursement rate. This reimbursement rate fully covers the costs incurred by the District.

These agreements have been reviewed and approved as to form and legal content by the Office of General Counsel.
