**SUMMARY EXPLANATION AND BACKGROUND:**  
District Staff determined that due to the following circumstances, the twelve (12) classrooms included in the Agreement with DECON Environmental & Engineering, Inc. was not needed at Tedder Elementary School:  
1) A thirty-six (36) classroom addition was scheduled to commence February 2005 at Tedder Elementary School.  
2) Change in student attendance boundaries increased enrollment at Tedder Elementary School.
