Project Overview:

This project consisted of the renovation of the auditorium which included new seating, flooring, acoustical panels, stage restrooms, entry ramp at foyer, ADA compliant restrooms (gymnasium and auditorium), replacement of air handler units, and installation of fire sprinklers.

Status of Work:

This project was completed and achieved substantial completion on March 4, 2011. However, the project did not receive a Certificate of Occupancy until 2013 due to required repairs on existing mechanical equipment that was not in the Contractor's scope of work.

Kev Issues:

The major issue attributable to Change Order Item #21 on this project was the delay in the mechanical equipment being repaired, which impacted the Contractor from obtaining the Certificate of Occupancy. Although the repairs were outside of the Contractor's scope of work, the mechanical equipment (i.e. exhaust fans) was located in areas that were remodeled by the Contractor. This change order for \$23,174.40 reimburses the Contractor for Builder's Risk Insurance from December 2011 through December 2013 and Owner Protective Liability Insurance from December 2012 through April 2014.

The major issue attributable to credit Change Order Item #22 was based on a future re-roofing project of the entire facility. After the cancellation of the phased replacement project in 2011, it was determined that existing Building 1 would require re-roofing. As the re-roofing design and construction had not begun on Building 1 (gymnasium), 2, and 5 under this contract, Staff determined that it would be more cost effective to engage one contractor to avoid multiple warranties. Therefore, a credit was requested in the amount of (\$221,336). In addition, the Contractor is being granted 430 days under this change order item, due to the delays beyond their control that was associated with the deletion of the roofing scope of work.

Recommendation and Remarks:

This Board action reconciles and closes all outstanding accounts, requests for time extensions, releases retainage in the amount of \$46,328, and grants Final Acceptance for the project.
