Approve the recommendation for award for the above contract. Contract Term: August 19, 2014 through June 30, 2017, 2 Years, 10 months; User Department: Student Transportation & Fleet Services; Original Award Amount: \$650,000; Vendor(s) Awarded: A1A Transportation, Inc., and World of Kids Transportation; M/WBE Vendor(s): None

### SUMMARY EXPLANATION AND BACKGROUND:

The School Board of Broward County, Florida, re-released Bid 14-064V2 for School Bus Transportation Services; two (2) bids were received. This bid provides extra-curricular transportation services to transport students, staff, chaperones, and others, to and from athletic events, scholastic events, and field trips. These services are used by schools, Student Transportation & Fleet Services Department, and Athletics and Student Activities Department.

This bid was re-released to add vendors to the pool of eight (8) qualified, awarded vendors under ITB 14-064V, which was approved by post approval on April 15, 2014, with a spending authorization of \$650,000. Two (2) vendors responded to this solicitation and are being recommended to be added to this contract.
