#### **SUMMARY EXPLANATION AND BACKGROUND:**

Workforce Education fees are established by the Legislature in the General Appropriations Act. The School Board must annually adopt a Fee Schedule. The fees for Community Education programs, also know as fee support, are set forth by the District. Over 175,000 students enroll annually in Career Technical, Adult and Community Education programs, courses and activities.
