**SUMMARY EXPLANATION AND BACKGROUND:**

On November 5, 2013, The School Board of Broward County, Florida, approved a charter application to open a new charter school for the start of the 2014-2015 academic year. At the June 24, 2014, Regular School Board Meeting, item L-10 The National Ben Gamla Charter School Foundation, Inc., was approved to defer the opening of the school until the 2015-2016 academic year. Ben Gamla Preparatory Charter School will serve students in grades 6-8 and will open in August 2015.
