RESOLUTION IN SUPPORT OF CONCUSSION MANAGEMENT PROTOCOLS INCLUDING NEUROCOGNITIVE TESTING FOR HIGH SCHOOL STUDENT ATHLETES

WHEREAS, a concussion is a disturbance in brain function that occurs following either a blow to the head, face, or neck or as a result of the violent shaking of the head or body; and

WHEREAS, a concussion resulting from playing in interscholastic sports may result in the rapid onset of neurological impairment and acute clinical symptoms such as chronic headache, fatigue, mental sluggishness, sleep difficulties, personality changes (e.g. increased irritability), sensitivity to light or noise, dizziness, and coordination difficulties as well as deficits in short term memory, concentration, problem solving, and general academic functioning that reflect a functional neurological disturbance; and

WHEREAS, the incidence of concussion leaves student-athletes vulnerable to conditions such as Second Impact Syndrome, which can result in death or permanent disability, or Post-Concussion Syndrome, which involves thinking, behavioral, and emotional difficulties that can last up to weeks, months, or even years after injury to the brain, should a student-athlete sustain a second concussion prior to the complete resolution of the primary injury; and

WHEREAS, the School Board of Broward County implements a series of concussion management protocols designed to prevent and manage concussions including the implementation of baseline and post injury neurocognitive testing; and

WHEREAS, concussion management protocols include:

- Annual pre-participation physical for all student athletes with medical history requirements on head injuries, concussions, severe headaches, tingling in extremities and memory loss,
- Agreements with Broward Health and Memorial Healthcare to provide state/nationally certified athletic trainers at all high schools. Athletic trainers serve as first responders for sports medicine issues including concussions,
- Adhere to Florida High School Athletic Association rule that any athlete who exhibits signs, symptoms or behaving consistent with a concussion (such as loss of consciousness, headache, dizziness, confusion or balance problems) shall be immediately removed from the contest or practice and shall not return to play until cleared by an appropriate health care professional,



- All Head, paid coaches and student athletes are required to view the online education course, "Concussion in Sports-What you need to know." An affidavit of compliance for the concussion course must be maintained by each high school and signed by the school principal and athletic director,
- All sports coaches are encouraged to attend on August 19, 2015, a sports medicine symposium sponsored by Broward Health at Parker Playhouse, which includes a presentation on "Concussion Prevention and Awareness for Youth Sports Coaches" by Stephen Russo, Ph.D.,
- Contest officials shall be cognizant of athletes who display signs, symptoms or behaviors of a concussion and immediately stop play for injury evaluation within the rules of the game. Once the patient has been removed from a contest due to a suspected concussion, the coach, athletic trainer and appropriate health care professional shall assume full responsibility for that athlete's evaluation and safety. The national certified athletic trainer will assist with sideline evaluation of a student athlete when the athlete is sent out of a game or practice,
- High school football players must sit out one play if their helmet comes off while the ball is live,
- All student athletes participating in interscholastic sports shall be required as a participating condition to take a baseline neurocognitive test. Neurocognitive tests which are brief, computer-administered, neurocognitive screening devices developed by experts in the field of sport-related concussion, scientifically validated to measure the effects of concussive injuries, and designed to help clinicians evaluate an athlete's recovery following concussion by assessing aspects of an athlete's cognitive functioning such as working memory, sustained and selective attention and reaction time, can be used to help objectively evaluate a concussed athlete's post injury condition and track their recovery for a safe return to play and thereby help to prevent or minimize the cumulative effects of concussion,
- No athlete shall return to play or practice on the same day of a suspected concussion,
- Any athlete suspected of having a concussion shall be evaluated by an appropriate health care professional,
- Any athlete with a suspected concussion shall be medically cleared by an appropriate health care professional prior to resuming participation in any practice or competition,
- After medical clearance, return to play shall follow a graduated protocol with provisions for delayed return to play based upon the return of any signs or symptoms,
- Adhere to National Operating Committee on Standards for Athletic Equipment (NOCSAE) to annually recondition every football helmet,
- Limit the lifespan of helmets to five years, and destroy all helmets after the five-year period,
- Every student athlete and parent shall be required to read and sign consent and release from Liability Certificate for concussion. Such certificate produced by the Florida High School Athletic Association shall educate parents and athletes on signs and symptoms of a concussion and action steps that must be taken; and



WHEREAS, the School Board of Broward County supports a comprehensive education campaign to increase awareness about concussion management, including prevention, symptoms and treatment developed with the assistance of Broward Health, Memorial Healthcare, Nova Southeastern, booster clubs and community organizations such as the Daniel Brett Foundation; and


WHEREAS, funding for the neurocognitive testing, called ImPACT, is jointly funded by the Broward County Athletic Association, Nova Southeastern University and Florida Community Bank;

NOW, THEREFORE, BE IT RESOLVED, that every high school within the jurisdiction of The School Board of Broward County, Florida shall support awareness and the protocols of concussion management.

**RESOLUTION IN SUPPORT OF ATTENDANCE AWARENESS MONTH

WHEREAS, cities and communities across the country are confronted with the issue of one in four students missing a month or more of school, placing them at risk of academic failure, drop out risk and reduced socialization; and

WHEREAS, it is the goal of the School Board of Broward County, Florida to increase student achievement. Research has shown a direct correlation between student attendance and academic achievement; and

WHEREAS, chronic absence, defined by Florida State Statutes as a student who has had at least five unexcused absences, or absences for which the reasons are unknown, within a calendar month, or 10 unexcused absences, or absences for which the reasons are unknown, within a 90-calendar-day period, may be exhibiting a pattern of non-attendance (F.S. 1003.26 (1) (b)), contributes to lower student achievement; and

WHEREAS, chronic absenteeism is a proven predictor of struggles in academics. Chronic absenteeism also increases the likelihood of dropping out; and

WHEREAS, The School Board of Broward County has partnered with community agencies such as The State Attorney's Office and state funded Children in Need of Services/Families in Need of Services (CINS/FINS) agencies to address the needs of students demonstrating chronic absence, both excused and unexcused; and

WHEREAS, ensuring and monitoring regular school attendance is the responsibility of all stakeholder groups in Broward County, Florida,

NOW, THEREFORE, BE IT RESOLVED that The School Board of Broward County, Florida, in conjunction with other agencies and organizations, hereby declares

September 2015 as Attendance Awareness Month

and urges everyone within its jurisdiction and under its authority to join in this annual observance.

WHEREAS, the first members of the Board of Public Instruction of Broward County, which included three members, were appointed by the Governor of Florida on July 13, 1915; and

WHEREAS, the School Board of Broward County, Florida has grown from three members to nine members who lead the sixth largest public school system in the nation, the second largest public school system in Florida, and since 1962, is the first fully accredited school district in the state; and

WHEREAS, Educating Today's Students to Succeed in Tomorrow's World is the vision statement of Broward County Public Schools under the auspices of the School Board of Broward County, Florida; and

WHEREAS, Broward County Public Schools is committed to educating all students to reach their highest potential as stated in its mission statement; and

WHEREAS, the School Board of Broward County, Florida is celebrating 100 years of service to Broward County, the State of Florida and the United States of America.


WHEREAS, Broward County Public Schools, Coordinated Student Health Services Department is now a Partner Agency with Feeding South Florida.







RESOLUTION IN SUPPORT OF CONSTITUTION DAY

SEPTEMBER 17, 2015

WHEREAS, on September 17, 1787 members of the Constitutional Convention signed the final draft of the United States Constitutional Convention; and

WHEREAS, Public Law 108-447, the Consolidated Appropriation Act, 2005 is currently federal law; and

WHEREAS, Section 111 of Public Law 108-447 details the requirements of a national Constitution Day; and

WHEREAS, Section 111 requires that Constitution Day be held on September 17 of each year; and

WHEREAS, Section 111 requires that when September 17 falls on a Saturday, Sunday, or holiday, Constitution Day shall be held during the preceding or following week; and

WHEREAS, Section 111 states that all educational institutions receiving funds from the Federal Department of Education are required to comply by implementing an educational program pertaining to the United States Constitution; and

WHEREAS, the School Board of Broward County, Florida is an educational institution receiving funding from the Federal DOE;

NOW, THEREFORE, BE IT RESOLVED, that The School Board of Broward County, Florida, in conjunction with Public Law 108-447, Section 111, of the Consolidated Appropriation Act, 2005 declares







WHEREAS, the future well-being of our schools and city depends on the value we place on our youth and in particular on our actions to provide these most vulnerable of our young people with opportunities to acquire the knowledge, skills and abilities they need to find and maintain stable housing and develop into healthy and productive adults; and

WHEREAS, district staff in partnership with numerous community agencies and organizations endeavor to remove barriers often faced by homeless students, yet the number of effective programs providing services and support to homeless youth in Broward County is only a fraction of what is needed to fully address the needs of these young people; and

WHEREAS, the Broward Schools Homeless Education Assistance Resource Team empowers homeless students and families through educational advocacy and support while promoting awareness in schools and the community; and

WHEREAS, the School Board of Broward County recognizes that youth homelessness continues to be a serious problem for many students and families in Broward County; and

WHEREAS, the purpose of this resolution is to educate the public about the many reasons people, especially youth, are hungry and homeless; including the shortage of affordable housing in Broward County for very low income residents; and to encourage support for homeless assistance as well as community service opportunities for students and school service organizations.

WHEREAS, the annual health care cost of asthma is approximately \$56 billion dollars; and





WHEREAS, the struggle for equality and justice has been and continues to be a grand inspiration in the hearts, minds and endeavors of people of all races, creeds and colors in the development of nations, cultures and the stability of economic systems; and

WHEREAS, the history of the emancipation of people of African descent has been a powerful and provocative lesson in human rights in this state, in our nation, and in the Western Hemisphere; and

WHEREAS, in this state, all blacks were emancipated from slavery by the enforcement of the Emancipation Proclamation, an executive order of President Abraham Lincoln during the Civil War. Although the order was signed on January 1, 1862, it took nearly two and a half years before it could be fully enforced in the state of Florida. The delay in enforcement was due to fact that this state was able to hold its capitol city as a Confederate state throughout the Civil War that split this nation; and

WHEREAS, The Knott House Museum in Tallahassee and the Florida Secretary of State each year re-enacts U.S. Army Brigadier General Edward Moody McCook reading an order on May 20, 1865, that emancipated all blacks in the state as part of re-affirming the state of Florida as a part of the United States; and

WHEREAS, Broward County Public School's has made notable efforts to preserve and infuse the history of Africans and African- Americans in its curriculum, its classrooms, and in its support of African-American heritage, including its support of the Old Dillard Museum, a site listed on the National Register of Historic Places for the past 25 years as the first public schoolhouse for blacks in Broward County; and

WHEREAS, the Old Dillard Museum and a host of its community supporters wish to joyfully recall the opportunities and responsibilities that emancipation afforded to African- Americans in this state, in this nation, and throughout the Western Hemisphere by holding a mini-festival. This mini-festival that will showcase musical arts such as jazz, and the performing arts; and

WHEREAS, a Florida Emancipation Day Mini-Festival will be held at Dillard Center for the Arts on Saturday, May 14, 2015, that honors the tradition of giving all people the opportunity to manage their own lives, to choose their own professions, and to enhance the development of their own cultural pursuits.



WHEREAS there are slightly over 500 licensed foster homes in Broward County, Florida.

WHEREAS, International Water Safety Day is celebrated to bring awareness to the ongoing drowning epidemic and educate people in becoming safer around the water;

WHEREAS, fatal unintentional drowning is the second leading cause of death for children 1 to 14 years of age, and the sixth leading cause of death for people of all ages;

WHEREAS, an estimated 388,000 people died from drowning, making drowning a major public health problem worldwide and accounting for nearly 10 percent of total global mortality;

WHEREAS, drowning is the third leading cause of unintentional injury death, accounting for 7 percent of all injury-related deaths;

WHEREAS, in Broward County 41 drowning fatalities occurred among children under the age of 5 (*Examiner's Office from 2009 through 11/2014*)

WHEREAS, in Broward County, there are:

- 124,580 residential pools
- 4,250 community pools
- 23 miles of Atlantic coastal beaches
- 165 miles of navigable canals
- 25 miles of intra-coastal waterways
- Countless ponds, lakes, spas, above-ground and portable pools
- An abundance of buckets, garden ponds, bathrooms, and containers in every neighborhood

WHEREAS, water safety education and water safety awareness can help curb the number of drowning fatalities;

WHEREAS, research shows that formal swimming lessons can reduce the risk of drowning by 88 percent among children aged 1 to 4 years old;

WHEREAS, water safety is a life skill that can be taught; and water safety education should be included in primary and secondary school education;

NOW, THEREFORE, BE IT RESOLVED, that The School Board of Broward County, Florida, hereby extends its support for:


