REQUESTED ACTION:

Approve the application for Wingate Oaks Charter School, Inc., (Wingate Oaks Charter School), to open a charter school serving grades K-12 for the 2015-2016 school year and authorize the Superintendent to issue a notice of approval. Subsequent School Board approval shall be required prior to the signing of a written charter school agreement establishing the operation of the charter school.
