Continuation of the Interagency Agreement with The School Board of Broward County, The Florida Department of Juvenile Justice, Florida Department of Children and Families, State Attorney Office, Law Enforcement Departments, and The Sheriff

REQUESTED ACTION:

Approve the continuation of the Interagency Agreement with The School of Broward County, The Florida Department of Juvenile Justice, Florida Department of Children and Families, State Attorney Office, Law Enforcement Departments and The Sheriff for the purpose of sharing information.

SUMMARY EXPLANATION AND BACKGROUND:

The School Board approved the initial Interagency Agreement on October 7, 1997. Revisions have been made as specified by statute. The Department of Juvenile Justice, Sheriff and Chiefs of Police are required by FS 985.04(1) to enter into an interagency agreement with The School Board for the purpose of sharing information about juvenile offenders. Locally, the Agreement was expanded to include additional stakeholders; the State Attorney's Office and the Florida Department of Children and Families to increase the effectiveness of the information and the intent of the statute.
