Recommendation to Reject all Bids -16-034T- Emergency Debris Clean Up and Removal Services

REQUESTED ACTION:

Approve the recommendation to reject all bids for the above contract. Bid 16-034T was advertised on June 8, 2015. A new bid will be advertised and presented for award at the November 3, 2015, Board meeting.

SUMMARY EXPLANATION AND BACKGROUND:

The School Board of Broward County, Florida (SBBC), received four (4) bids for Bid 16-034T, Emergency Debris Clean Up and Removal Services. The bidders were: Bergeron Emergency Services, Inc.; Ceres Environmental Services, Inc.; DRC Emergency Services, LLC; and TFR Enterprises, Inc. A copy of the complete bid is available at: http://www.broward.k12.fl.us/supply/agenda/16-034T-Debris.pdf As of June 18, 2015, the Code of Federal Regulations, issued by the Federal Emergency Management Agency, was revised; therefore, all bids will be rejected and the solicitation will be rebid with revised specifications. The District currently utilizes Bid 11-024T for emergency debris clean-up in the event the District experiences a severe storm.
