SUMMARY EXPLANATION AND BACKGROUND:

The School Board of Broward County, Florida (SBBC), received seven (7) bids for Bid 16-014R, HVAC-R Parts and Supplies. The purpose of the bid is to purchase HVAC-R Parts and Supplies to replace, repair and maintain air conditioning, heating, refrigeration, and ventilation equipment located throughout the schools and administrative sites in order to provide a comfortable and safe environment. All sites are equipped with an HVAC system designed to maintain proper temperature and humidity levels and schools will also have a refrigeration system to keep food at suitable temperatures. The main items used are: compressors, refrigerant, oil, oil filters, motors, pumps, sensors, piping and pipe fittings, relays, and switches.
