The primary objectives of the audit were to review the monitoring process and controls by management administering the procurement of installation of video surveillance equipment and repairs; determine whether the invoices paid for the projects and repairs were in compliance with prices approved by the Board for Bid No. 28-134T and Piggyback Agreement No. 55-045C; analyze the rendor installation and repair processes and billings, to ascertain whether work performed was completed in an effective and efficient manner; and report recommendations to the administration, if needed.
