REQUESTED ACTION:

Approve the Agreement between The School Board of Broward County, Florida and Florida Atlantic University. The Agreement period is from July 1, 2015, through June 30, 2016.

SUMMARY EXPLANATION AND BACKGROUND:

The Florida Department of Education Centers of Excellence in Elementary Teacher Preparation grant was awarded to the College of Education at Florida Atlantic University (FAU) in an effort to improve pre-service (K-5) teacher preparation in core subject areas and to enhance field experiences. To achieve the grant priorities, the College of Education at FAU has partnered with FAU's Colleges of Science, Arts and Letters, and Honors College, the school districts of Broward and Palm Beach counties, Learning Sciences International, and New Teacher Center. As a subawardee of FAU, the District will provide data to evaluate the progress of project goals such as: 1) Improve candidate content knowledge of the increasingly rigorous requirements for K-5 students and prepare candidates for graduate coursework; and 2) Identify and train highly effective teachers to serve as cooperating teachers in accordance with Florida Statutes. This Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel. This Agreement will be executed by FAU after School Board approval.
