First Amendment to Twenty-Four (24) Classroom Agreement with the City of Parkland

REQUESTED ACTION:

Approve the First Amendment to Twenty-Four (24) Classroom Agreement between The School Board of Broward County, Florida and the City of Parkland (City).

SUMMARY EXPLANATION AND BACKGROUND:

n order to help accommodate for the increase in students from planned residential development in the City, the original Classroom Addition Agreement (Agreement) was executed by the School Board on October 9, 2014 and by the City on October 15, 2014. The Agreement stated that in exchange for the City's initial payment to the School Board in the amount of seven million seven hundred twenty four thousand dollars (\$7,724,000) (Contribution Payment), the School Board would construct, maintain, and operate twenty-four (24) permanent classrooms at public school(s) within the corporate limits of the City and remove twenty-four (24) portable classrooms. The First Amendment to Twenty-Four (24) Classroom Agreement with the City of Parkland has been reviewed and approved as to form and legal content by the Office of the General Counsel.
