### **REQUESTED ACTION:**

Approve the Authorization to Advertise for Design/Build Services, Walter C. Young Middle School, HVAC & Re-Roof, Project No. P.000538.

### **SUMMARY EXPLANATION AND BACKGROUND:**

Scope: Replacement of HVAC Equipment in Buildings 1, 4, 5, 6, 7, 8, and 10; Exterior Renovations at Buildings 8 and 9; Reroofing of Buildings 2, 4, 6, 7, 8, 9, 13, and 15.

Budget: \$5,176,660

Selection for the services shall be in accordance with Board Policy 7003. The Qualification Selection Evaluation Committee shall shortlist, interview, and recommend one firm for selection in the evaluation of the proposer's qualifications. The Board will award contract to the Desian/Build firm.
