

**AMENDMENT NO. 1**  
**TO THE**  
**CERTIPOINT AUTHORIZED TEST CENTER™ AGREEMENT**

This Amendment No. 1 to the **CERTIPOINT AUTHORIZED TEST CENTER™ AGREEMENT**, dated with an Effective Date of November 12, 2014, as amended from time to time (the "Agreement"), by and between Certipoint, a business of NCS Pearson, Inc. with offices at 5601 Green Valley Drive, Bloomington, MN 55437 ("Certipoint") and The School Board of Broward County, Florida a body corporate and political subdivision of the State of Florida, having its principal offices at 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301 ("Company" or "Licensee") is entered into as of the date of the last signature below.

Capitalized terms not otherwise defined herein shall have the same meanings as those assigned to them in the Agreement.

**WHEREAS**, the parties entered into the Agreement effective November 12, 2014; and

**WHEREAS**, the parties now wish to amend the Agreement pursuant to this Amendment No. 1 to the Agreement to extend terms for one year.

**NOW THEREFORE**, for good and valuable consideration the receipt of which is hereby acknowledged, the parties hereto agree as follows:

**1. Section 10.1 is changed as underlined below:**

"Section 10.1. Term. This Agreement shall commence on the Effective Date and, subject to Company satisfying its initial purchase requirement as detailed in Section 4.4 and unless sooner terminated pursuant to provisions herein, continue for a term of twenty-four (24) months from the Effective Date and shall expire on November 12, 2016."

Except as provided in this Amendment No. 1, all terms and condition of the above referenced Agreement shall remain in full force and effect. If there is conflict between this Amendment No. 1 and the Agreement or any earlier Amendment, the terms of this Amendment No. 1 will prevail.
