Amendment No. Two to Agreement No. 2014-2015-CR-2335-Icon between CareerSource Broward and The School Board of Broward County, Florida

REQUESTED ACTION:

Approve the Amendment to the Agreement between CareerSource Broward and The School Board of Broward County, Florida.

SUMMARY EXPLANATION AND BACKGROUND:

The School Board of Broward County, Florida has been awarded a grant in the amount of \$493,565 for the Out of School Youth Program funded by CareerSource Broward from Federal Workforce Innovation and Opportunity Act (WIOA) funds. The program will serve two hundred (200) youth who are between the ages of 16-24, and meet WIOA eligibility requirements for out-of-school youth who have not completed high school or obtained a GED. These funds will provide additional assistance to obtain the high school credential. The program design includes individual career pathway plans, employability skills development, financial literacy skills, and on the job training delivered by three state-certified teachers and two job coaches.
