REQUESTED ACTION:

Approve the application for Championship Academy of Distinction at Davie High School, Inc., (Championship Academy of Distinction High School), to open a charter school serving grades 9-12 for the 2016-2017 school year and authorize the Superintendent to issue a notice of approval. Subsequent School Board approval shall be required prior to the signing of a written charter school agreement establishing the operation of the charter school.
