Second Amendment to the Existing Declaration of Restrictive Covenants Related to Land Use Plan Amendment PC 06-30

#### **REQUESTED ACTION:**

Approve the Second Amendment to the existing Declaration of Restrictive Covenants (DRC) related to Land Use Plan Amendment (LUPA) PC 06-30 as proposed by SPL Holdings, LLC and SPL South Holdings, LLC for the proposed development of 496 single family residential units in the Sabal Palm Development, located in the City of Tamarac.

#### SUMMARY EXPLANATION AND BACKGROUND:

Approval of the Second Amendment to the existing DRC for LUPA PC 06-30 is being requested by SPL Holdings, LLC and SPL South Holdings, LLC to assure that the revised residential units (496 single family units) proposed in the development are consistent with the plat application filed with the Broward County Commission. The Second Amended DRC has been reviewed and approved as to form and legal content by the Office of the General Counsel.
