REQUESTED ACTION:

Approve the recommended changes to Pages 9 and 15 of the 2015-2016 Organizational Chart.

SUMMARY EXPLANATION AND BACKGROUND:

At the June 23, 2015 Regular School Board Meeting, Agenda Item CC-5 (C-024: Manager, Emergency Management & Fire Chief Official) and IIβ (Page 15 only) were deferred to the July 21, 2015 Special School Board Meeting. These companion items were intended to assign the Chief Fire Official title and performance responsibilities to the Manager, Emergency Management position. After further consideration and discussion with the Broward Fire Chiefs Association, an alternative recommendation is being presented for consideration. This new structure will create a single authority within the District to oversee all fire safety related issues.
