EXECUTIVE SUMMARY

Approve Amended RFP Forms for Design/Build Services for Blanche Ely High School Building Renovations, P.001646, RFP 16-043F and Northeast High School, GOB Renovations, P.001684, RFP 16-072F and Stranahan High School, GOB Renovations, P.001683, RFP 16-071F

GENERAL OVERVIEW:

Approval of Agenda items J-1, J-4, and J-5 (Blanche Ely, Stranahan, and Northeast Authorizations to Advertise) occurred on November 3, 2015. During discussion of these items, several questions arose concerning the appropriateness of the Design/Build method to deliver projects encompassing significant renovation scope. Staff acknowledged the concern and advised the impetus for bringing these projects forward in their current form was a reflection of the initial vision for program delivery. The Design/Build form had been utilized previously to execute other recent projects, and by utilizing this form, the commitment to initiate construction for these projects in the summer of 2016 could be met. Further, staff advised that there would be ongoing evaluation of the delivery method and RFP structure to optimally deliver projects, recognizing the transition to a new Chief Facilities Officer and the recommendations of Heery, the District's new Owner's Representative.

Since the November 3rd Regular School Board Meeting, the pre-bid conferences for the Northeast HS and Stranahan HS projects have been held. The feedback from the construction community reinforced the concern about whether the current structure of the Design/Build RFP is best suited to deliver large-scale renovation projects. Additionally, there were concerns raised about an insufficient amount of time allocated for the development of proposals. In an effort to minimize the risk associated with not receiving a sufficient number of quality proposals, it is recommended that the revised RFP structure be approved, and an addendum issued to release the revised document to the bidding community.

Some of the more significant revisions to the RFP Form pertain to Bid Price and Breakdown, Cost of Service Scoring, Schedule for Proposal Submittal, and Final GMP. A description of the original and revised approaches for the noted items is outlined in the table below. Although the revised structure warrants approval by the Board and issuance of an addendum, the impact to the schedule is minimal and it is anticipated that the revised structure will enhance interest and participation by potential proposers.
