Resolution on behalf of the BCCPTA/PTSA Founder's Day

Recognizing and commending the Broward Congress of Parents and Teachers; declaring Wednesday, February 17, 2016, as Broward PTA and National PTA Founder's Day; and

WHEREAS, as the largest volunteer child advocacy association in the nation, National Parent Teacher Association (PTA) reminds our country of its obligations to children and provides parents and families with a powerful voice to speak on behalf of every child while providing the best tools for parents to help their children be successful students; and

WHEREAS, National PTA works in cooperation with many national education, health, safety, and child advocacy groups, to collaborate on projects that benefit children and bring valuable resources to its members; and

WHEREAS, currently PTA has over 4 million members nationwide and over 27,000 members within Broward County; and

WHEREAS, for more than a 100 years, PTA has provided support, information and resources to families focused on the health and education of children. The organization was founded in 1897 in Washington DC as the National Congress of the Mothers by Alice McLellan Birney and Phoebe Apperson Hearst.
