Transportation Agreements for Cities and Non-Profit Organization Recreation Programs

REQUESTED ACTION:
Approve agreements between The School Board of Broward County, Florida, and the City of Coral Springs, City of Lauderdale Lakes and the non-profit organization of New Horizon Community Development Corporation, Inc., to provide school bus transportation for recreational programs for the period of one year.

SUMMARY EXPLANATION AND BACKGROUND:
The transportation agreements allow the cities and non-profit organizations to utilize District buses for city/organizational sponsored recreation programs and events that are dependent on transportation.
