Ms. Baltazar reported that the committee is in the final stage of completing the accreditation report for HACC. She acknowledged that Ziana Taylor was student of the month and the Secondary Academic Committee will continue to test into May.

Mrs. Bolinger updated the committee on the participation of students for the Saturday classes and provided great reviews from students and participation. She also indicated that the Workforce students

will be taking a fieldtrip in the upcoming weeks to H.D Perry Middle School and they will be participating in their monthly gathering of celebrating success and networking in the auditorium next Thursday April 7, 2016.

Mr. Overstreet reported that the anti-bullying march was conducted at Piper Bay High School and the SADD group of HACC will be hosting an assembly on Thursday March 31, 2016 with a special guest speaker from the organization.
