Research Methodology	According to a study published in <i>Gifted Child Today</i> (Ozturk and Debelak, November 31, 2008), competitive events may provide the "initial motivation" and catalyst for helping students to discover the joy of learning academic competitions can provide motivation for students to study, learn new material, and reinforce previously learned material so that they will be ready to compete (and collaborate) with their peers from other schools both regionally and nationally—not just in games but also in academic and work environments. This type of motivation is difficult to provide in a normal classroom environment. While it can be argued that this is solely extrinsic motivation and that students should not be dependent on it, it can nevertheless serve as the spark that ignites a discovery of the joy of learning science and math.

Project Description	The "Cover Your Subjects Quilt" is an on-going project that promotes student engagement and learning through art. The objective is for the students to "show what they know" by drawing and painting a depiction of the concept they are learning about. The students then create three quilt pieces for at least three different subject areas so they can prove he or she understands and has mastered an academic standard. First, students will depict what they learned in a drawing (a chart, graphic organizer, picture) that shows a clear understanding of the concept. The picture will then be transferred to a quilt piece. Once all the pieces are completed a volunteer will sew them all together while the students watch and learn how a sewing machine works. The completed quilt will be hung in the school's media center.
Evaluation Plan	To evaluate the effectiveness of this project I will provide the students with a rubric to help them understand my expectations for mastery. It will list the standards we will be covering and what it takes to master the standard. I will also create a survey for students, staff and community to give their input about what they thought about the project.
Research Methodology	With projects like "Cover Your Subjects Quilt" students have an opportunity to express what they know in fun ways rather than traditional paper or book lessons. E-Readers purchased with the grant will provide students opportunities to learn in different ways and utilize popular online academic programs. Even reluctant learners enjoy using E-readers.
