The original agreement with The Learning Excellence Foundation of West Broward County, Inc., was approved at the May 15, 2001, Regular School Board Meeting, Item I-2. On August, 18, 2008, the Charter School Agreement with The Learning Excellence Foundation of West Broward County, Inc., on behalf of Imagine Charter School at Weston–5111, was renewed for a term of five years at the Regular School Board Meeting, Item F-26. On August 7, 2012, The Learning Excellence Foundation of West Broward County, Inc., on behalf of Imagine Charter School at Weston – 5111, received the 1st Amendment of its Charter School Agreement to recognize the School's state designation as a high-performing charter school and modifying the length of contract to June 30, 2025, at the Regular School Board Meeting, Item E-1.

The original agreement with Imagine West Broward, Inc., was approved at the May 15, 2012, Regular School Board Meeting, Item F-2. This agreement is effective for a five-year period, commencing on July 1, 2012 and to conclude on June 30, 2017.

Section 1002.33(7)(c), Florida Statutes, states: "A charter may be modified during its initial term or nay renewal term recommendation of the sponsor or the charter school's governing board and the approval of both parties to the agreement. Modification may include, but not limited to, consolidation of multiple charters into a single charter if the charters are

operated under the same governing board and physically located on the same campus, regardless of the renewal cycle."

The Learning Excellence Foundation of West Broward County, Inc., desires to amend its Charter School Agreement by modifying the grade levels served to include grades 6-8 students previously enrolled in Imagine Middle School West – 5402, and to increase its contract capacity from 1050 to 1075 students thereby establishing a consolidated K-8 charter school. The current location of the school has provided documentation that supports this increase.

Imagine West Broward, Inc., desires to conclude its Charter School Agreement known as Imagine Middle School West – 5042 as of June 30, 2016, as part of the establishment of the consolidated K-8 charter school.

Imagine Charter School at Weston is located in District 6.

The governing board members of The Learning Excellence Foundation of West Broward County, Inc., reside in Broward County, Florida.
