TITLE:
Transportation Agreements for Cities and Non-Profit Organization Recreation Programs

REQUESTED ACTION:
Approve agreements between The School Board of Broward County, Florida, and the City of Coral Springs; City of Deerfield Beach; City of Lauderdale Lakes; City of Pompano Beach and the non-profit organizations of After School Programs, Inc.; New Horizon Community Development Corporation, Inc.; and the YMCA of South Florida, Inc., to provide school bus transportation for recreational programs for a period from board approval date through June 30, 2017.

SUMMARY EXPLANATION AND BACKGROUND:
The transportation agreements allow the cities and non-profit organizations to utilize District buses for city/organizational sponsored recreation programs and events that are dependent on transportation. City/organization sponsored recreation programs provide a valuable service to their respective communities. These Agreements have been reviewed and approved as to form and legal content by the Office of the General Counsel.
