TITLE:
First Amendment to item FF-1, approved on 5/17/16, at RSBM as part of the Instructional Materials Adoption for Spanish S

REQUESTED ACTION:
The instructional materials for Spanish S was approved on 5/17/2016 RSBM (FF-1). After this meeting, it was noted that the recommended instructional materials for Secondary Spanish for Speakers Grades 7-12 (textbook and supplemental materials) had the wrong publisher information (Descubre 1-3, Vista Higher Learning). We are requesting an amendment to this adoption to reflect the correct instructional materials recommendation for Secondary Spanish for Speakers Grades 7-12 to be En Espanol, Santillana, USA Publishing Co. All other instructional materials brought to the Board on 5/17/16 were correct.

SUMMARY EXPLANATION AND BACKGROUND:
Florida Statute 1006.40 (5) requires the following steps in approving recommended instructional materials for use district-wide.
Online access to student editions of the committee recommended instructional materials for 20 days.
An open, noticed school board hearing during which the public may comment on the recommended instructional materials. (April 5, 2016)
An open, noticed public meeting to approve the annual instructional materials plan. The plan identifies the instructional materials that will be purchased through the district school board instructional materials review process. (May 17, 2016)
Amendment approved by the Board. (June 15, 2016)
