The purpose of the Public Charter Schools Federal Grant Program is to increase the number of high-quality charter schools and to improve student achievement by providing financial assistance for the planning, program design and implementation costs for charter schools. Priority is to first-year charter schools approved to open during the 2016-2017 school year.
