On May 17, 2011, The School Board of Broward County, Florida approved a Charter School Agreement enabling New Alternative Education High School of Broward County, Inc. to open a charter school named Mavericks High School of North Broward County. This contract was effective for five years and ends on June 30, 2016.

Pursuant to Section 1002.33(8)(b), Florida Statutes, a school's Charter School Agreement may be renewed subject to a program review and provided that none of the statutory grounds for non-renewal have been documented.

Additionally, the School desires to change its name from Mavericks High School of North Broward County to Andrews High School.

The Superintendent's Charter School Review Committee has reviewed and analyzed the Charter Renewal Program Review submitted by New Alternative Education High School of Broward County, Inc., (Andrews High School f/k/a/ Mavericks High School of North Broward County – 5009), and has conducted On-Site Programmatic Reviews (OSPR) and has recommended a five-year renewal of its Charter Agreement. This five-year renewal term will afford the Charter School an opportunity to continue its operations while demonstrating its ability to remediate Educational Performance deficiencies as required by Section 1002.33, Florida Statutes.

If, at any time the Sponsor finds during an on-site programmatic review, a data review, or via any other process, that the Charter School fails to implement the remedial measures listed below and included in the renewal Charter Agreement, such non-compliance will be considered grounds for termination of the renewed Charter Agreement or the declination of any further contract renewal.

DEFICIENCIES FOUND IN THE RENEWAL PROGRAM REVIEW/ON-SITE PROGRAMMATIC REVIEW

Following are the specific sections of the Renewal Program Review or On-Site Programmatic Reviews that did not meet or partially met the renewal criteria, thus contributing to the recommendation of a five-year renewal of the Charter Agreement with specific mitigating language:

EDUCATIONAL PERFORMANCE:

The Superintendent's Charter Review Committee reviewed the Educational Performance of the Charter School as presented in the Renewal Program Review and as observed during On-Site Programmatic Reviews. Staff has determined that New Alternative Education High School of Broward County, Inc. (Andrews High School, f/k/a Mavericks High School of North Broward County – 5009) has the following deficiencies:

Deficiency 1 – State Accountability:

- Failure to meet the state's student performance requirements.

Remedial Measures:

- The Charter School shall test a minimum of 80% of students annually for the entire term of the charter agreement.
- The Charter School shall achieve a school improvement rating of "Maintaining" annually for the entire term of the Charter Agreement. "Maintaining" is defined as having a sufficient percentage of the students that attend the school making learning gains.

Deficiency 2 – Exceptional Student Education:

- Failure to list an evaluation specialist on the Parent Participation Form.
- Failure to provide to parents the 10-day notice Gifted Parent Participation Form.
- Failure to provide to parents the second notice Gifted Parent Participation Form.
- Failure to list the correct purpose of the meeting on the Gifted Parent Participation Form.
- Failure to generate a Notice of Proposal/Refusal upon a change of services of 50% or greater.

Remedial Measures:

- The Charter School shall list an evaluation specialist on the Parent Participation Form.
- The Charter School shall provide to parents the 10-day notice Gifted Parent Participation Form.
- The Charter School shall provide to parents the second notice Gifted Parent Participation Form.
- The Charter School shall list the correct purpose of the meeting on the Gifted Parent Participation Form.
- The Charter School shall generate a Notice of Proposal/Refusal upon a change of services of 50% or greater.

Deficiency 3 – English Language Learners:

- Failure to provide evidence of programmatic assessments.
- Failure to provide evidence of ELL Plans for the ELL folders reviewed.
- Failure to provide evidence of updated ELL Plans for the 2015-2016 school year.
- Failure to provide evidence of updated ESOL program panels on TERMS.
- Failure to follow procedures for convening ELL Committee meetings.
- Failure to provide evidence of annual reviews.
- Failure to provide evidence of REEVALS.
- Failure to provide evidence of adapted assessments based on English Language Proficiency.
- Failure to provide evidence of student work with accommodations clearly documented.
- Failure to provide evidence of monitoring as required for exited students (LF).
- Failure to provide evidence that current data guides instruction.
- Failure to provide evidence that teachers know the language classification of their ELLs.
- Failure to provide evidence of ESOL strategies documented for each lesson.
- Failure to provide evidence of home school communication provided in the parent's home language.
- Failure to provide evidence of school information provided in multiple languages.

- Failure to provide evidence that registration forms were provided to parents in their home language.

Remedial Measures:

- The Charter School shall provide evidence of programmatic assessments.
- The Charter School shall provide evidence of ELL Plans for the ELL folders reviewed.
- The Charter School shall provide evidence of updated ELL Plans for the 2015-2016 school year.
- The Charter School shall provide evidence of updated ESOL program panels on TERMS.
- The Charter School shall follow procedures for convening ELL Committee meetings.
- The Charter School shall provide evidence of annual reviews.
- The Charter School shall provide evidence of REEVALS.
- The Charter School shall provide evidence of adapted assessments based on English Language Proficiency.
- The Charter School shall provide evidence of student work with accommodations clearly documented.

It is requested that The School Board of Broward County, Florida, approve the renewal of the Charter School Agreement for New Alternative Education High School of Broward County, Inc., (Andrews High School f/k/a Mavericks Charter High School of North Broward County– 5009), for a five-year period starting on July 1, 2016 and ending on June 30, 2021.
