TITLE: Revisions to Policy 6000\_1 Student Progression Plan

REQUESTED ACTION: Adopt revisions to Policy 6000.1 Student Progression Plan at this Final Reading.

### SUMMARY EXPLANATION AND BACKGROUND:

The District Policy 6000.1 Committee convened throughout the school year to address issues and formulate proposed changes for the 2016-2017 school year. A broad representation of District and school-based staff, with parents and students participated in the committee. Changes and rationale are reflected within the strikethrough version of the policy. Certain policy language is dependent upon adoption of Policy 5.5, Attendance, at the June 21, 2016 Regular School Board Meeting, prior to final adoption. These revisions were discussed at the April 26, 2016 School Board Workshop and May 24, 2016 Public Rule Development Workshop for the first reading. This policy was advertised on April 1, 2016.

## CC-6 Amendment June 21, 2016 Regular Meeting

### Motion to Amend (Carried)

Motion was made by Mrs. Rupert, seconded by Mrs. Bartleman and carried, to amend Policy 6000.1 to incorporate the revised language moved from Policy 5.5 - Attendance, pertaining to Make-up Work to read as follows:

### MAKE-UP WORK

Make-up work is allowed for full credit and grade for excused absences.

Make-up work is allowed for unexcused absences with the following stipulations:

1. **Elementary schools:** Make-up work is allowed for full credit and grade.
2. **Middle Schools:** Make-up work is allowed for full credit and grade. For high school courses taken at the middle school level, high school guidelines below apply.
3. **High Schools:** Make-up work is allowed for unexcused absences. Teachers may, at their discretion, record a 10% reduction in the grade for tests and major projects that meet standards or proficiency. Teachers may also, at their discretion, record the lowest passing grade (e.g. "D" or "60") for homework, unless less than 50% of the work was successfully completed.

All make-up work must be submitted within two days, not including the day of return, for each day of an absence. Previously assigned work is due the day of return. Under extenuating circumstances and at teacher's discretion, additional time may be allowed.
