The formal written protest shall be filed within ten (10) days after the date the notice of protest is filed. Failure to file a notice of protest or failure to file a formal written protest shall constitute a waiver of proceedings under this chapter. Section 120.57(3)(b), Florida Statutes, states that "The formal written protest shall state with particularity the facts and law upon which the protest is based." Saturdays, Sundays, state holidays and days during which the school district administration is closed shall be excluded in the computation of the 72-hour time period provided. Filings shall be at the office of the Director of Procurement & Warehousing Services, 7720 West Oakland Park Boulevard, Suite 323, Sunrise, Florida 33351. Any person who files an action protesting an intended decision shall post with the School Board, at the time of filing the formal written protest, a bond, payable to The School Board of Broward County, Florida, (SBBC), in an amount equal to one percent (1%) of the estimated value of the contract. Failure to post the bond required by SBBC Policy 3320, Part VIII, Purchasing Policies, Section N, within the time allowed for filing a bond shall constitute a waiver of the right to protest.





Reject proposal from Therapy Source, Inc. Minimum Eligibility states that in order to be considered for award and to be further evaluated, Proposer must meet or exceed the following criteria in this section. Failure to provide the information requested will result in disqualification of proposal. A response to Section 4.2.2 for Minimum Eligibility, by the Proposer, states that the licensure is not available for submission with this proposal; therefore, their proposal is disqualified.

Reject proposal from Staffing Options and Solutions, Inc. Section 4.2.2 states that a principal officer or manager of services of the firm must hold a current Florida license to practice either occupational or physical therapy issued by the Department of Health from the State of Florida. Proposer submitted licensure from the State of Indiana; therefore, their proposal is disqualified.

Reject proposal from Soliant Health, Inc. Section 4.2.2 states that a principal officer or manager of services of the firm must hold a current Florida license to practice either occupational or physical therapy issued by the Department of Health from the State of Florida. Proposer stated, "We do not have a principal officer or manager who is a Florida licensed OTR or PT"; therefore, their proposal is disqualified.

Reject proposal from Educational Based Services. Section 4.2.2 states that a principal officer or manager of services of the firm must hold a current Florida license to practice either occupational or physical therapy issued by the Department of Health from the State of Florida. Proposer must provide a copy of the license and title with their submitted proposal in order to meet the minimum eligibility requirements. Section 4.2.2. was not answered in their proposal; no certification was submitted with their proposal for the principal officer or manager; therefore, their proposal is disqualified.

Reject proposal from Providastaff, LLC d/b/a EDU Healthcare. Section 4.2.2 states that a principal officer or manager of services of the firm must hold a current Florida license to practice either occupational or physical therapy issued by the Department of Health from the State of Florida. Section 4.2.2. was not answered in their proposal; no certification was submitted with their proposal for the principal officer or manager; therefore, their proposal is disqualified.

Reject Items 4.4.3.1.2 and 4.4.3.1.4 for All Source Recruiting d/b/a Ardor Health Solutions. Sections 4.4.3.1.2 and 4.4.3.1.4 state that Proposer shall not exceed the stated rates for these sections. Rate was not to exceed \$45.00; Proposer offered \$49.00; therefore these items are rejected.

Simpson Group Enterprise Inc. was removed from the Recommendation and Tabulation, on May 19, 2016, since their company will be relocating to North Carolina and will not be able to perform the services on this contract.
