

**SEVENTH AMENDMENT TO
EMPLOYMENT AGREEMENT**

THIS SEVENTH AMENDMENT TO EMPLOYMENT AGREEMENT is made and entered into as of this 21st day of June 2016, by and between

THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA
(hereinafter referred to as "SBBC"),
a body corporate and political subdivision of the State of Florida,
whose principal place of business is
600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

MARYLIN BATISTA-McNAMARA
(hereinafter referred to as "BATISTA-McNAMARA"
or
"DEPUTY GENERAL COUNSEL")
whose principal place of business is
600 Southeast Third Avenue, Fort Lauderdale, Florida 33301.

WITNESSETH:

WHEREAS, SBBC and BATISTA-McNAMARA entered into an Employment Agreement, dated on or about October 7, 2008 (hereinafter "Employment Agreement"); and

WHEREAS, SBBC subsequently amended the Employment Agreement on September 1, 2009, September 21, 2010, October 18, 2011, May 21, 2013, June 24, 2014 and May 19, 2015;
and

WHEREAS, the current term of employment expires on June 30, 2016; and

WHEREAS, the parties mutually desire to extend the term of employment for an additional year as set forth herein.

NOW THEREFORE, in consideration of the premises and mutual agreements herein provided, the parties hereby agree as follows:

1. **RECITALS.**

The foregoing recitals are true and correct and incorporated herein by reference.

2. **EMPLOYMENT AND TERM.**

The following should be added to paragraph 2 of the Employment Agreement:

SBBC hereby employs BATISTA-McNAMARA as DEPUTY GENERAL COUNSEL, and BATISTA-McNAMARA hereby accepts and agrees to such employment, for an additional year, commencing July 1, 2016 and ending June 30, 2017.

3. **COMPENSATION.**

The following should be substituted as paragraph 4(A):

A. Salary / Compensation. For services rendered by the DEPUTY GENERAL COUNSEL pursuant to this Agreement, SBBC shall pay to and provide for the DEPUTY GENERAL COUNSEL the salary and other benefits described in this Agreement.

The DEPUTY GENERAL COUNSEL's salary for the 2015-2016 school year shall be adjusted consistent with the same percentage and terms awarded to ESMAB for the 2015-2016 school year.

4. **OTHER PROVISIONS IN EFFECT.**

Except as expressly provided herein, all other portions of the Employment Agreement as amended remain in full force and effect.
