SUMMARY EXPLANATION AND BACKGROUND:
The School Board of Broward County, Florida, received forty-three (43) bids in response to ITB 16-006V - School and Department Furniture. This request is to recommend award to forty-one (41) vendors that will supply classroom and office furniture to the District. This Bid includes a single-fixed percentage discount from manufacturer's catalog/list price and also includes furniture with firm-fixed pricing that is consistently used throughout the District for both schools and departments.
