

EXECUTIVE SUMMARY

Below is an executive summary for the Continuation Agreement between The School Board of Broward County, Florida and, National Academy Foundation (NAF), which supports the academic and personal enrichment of students, enrolled within NAF programs.

Status	Request approval of the continuation Agreement between National Academy Foundation and The School Board of Broward County, Florida. The term of this agreement shall be for a period of three (3) years from the date it is fully executed by both parties.
Funds Requested	\$107,600 for the 2016-17 school year and \$59,200 per year for 2017-18 and 2018-19 school years
Financial Impact Statement	There is a financial impact of \$107,600 for the 2016-17 school year and \$59,200 per year for 2017-18 and 2018-19 school years. The source of funds is the Carl Perkins Secondary Grant. There is no additional financial impact to the District.
Schools Included	Broward Public Schools currently has 26 successful NAF academies: Academy of Finance, Academy of Engineering, Academy of Health Science, Academy of Information Technology, and Academy of Hospitality & Tourism at the following 20 schools: Atlantic Technical High, Blanche Ely High, Charles W. Flanagan High, Cooper City High, Coral Glades High, Cypress Bay High, Deerfield Beach High, Dillard High, Everglades High, J.P. Taravella High, Marjorie Stoneman Douglas High, McArthur High, Miramar High, Monarch High, Northeast High, Piper High, Plantation High, South Broward High, Stranahan High, Western High. This agreement will expand the NAF programs by adding 11 new NAF Academies within the following High Schools: Blanche Ely High, Dillard High, Flanagan High, Fort Lauderdale High, Hollywood Hills High, Lauderhill High, McArthur High, Piper High, South Plantation High.

Project Description	Broward County Public Schools currently has twenty six (26) successful NAF Academies in the following areas: Engineering, Finance, Health Science, Hospitality & Tourism, and Information Technology. This agreement affords students with additional opportunities to become College & Career ready by allowing students to participate in Internship experiences with a variety of work place opportunities and industry specific curriculum.
Evaluation Plan	National Academy Foundation requires each NAF Academy school to create an extensive on-line Academy Assessment, in the NAF Data Center. This assessment is evaluated by NAF officials to determine the areas in which the school's academy is excelling, and in which areas they need additional assistance.
Research Methodology	Evaluation of the success of each academy is completed annually by NAF officials, as well as experts with which NAF contracts, from throughout the NAF network in the United States. The methodology measures specific academy performances against other academies in the nationwide NAF network.
