#### SUMMARY EXPLANATION AND BACKGROUND:

This request is to renew Bid 15-004R - Locks, Keys, Related Security and Door Hardware and approve an additional spending authority of \$800,000 for one (1) year from October 1, 2016, through September 30, 2017. This manufacturer list catalog bid enables Physical Plant Operations to purchase a wide array of these commodities for every type of door and lock applications.
