**SUMMARY EXPLANATION AND BACKGROUND:**  
This request is to renew Bid 15-004R - Locks, Keys, Related Security and Door Hardware and approve an additional spending authority of \$800,000 for one (1) year from October 1, 2016, through September 30, 2017. This manufacturer list catalog bid enables Physical Plant Operations to purchase a wide array of these commodities for every type of door and lock applications.

**FINANCIAL IMPACT:**  
The estimated financial impact to the District will be \$800,000. The contract award amount was for \$1,750,000. The financial impact amount represents an estimated contract value; however, the amount authorized will not exceed the estimated contract award amount.
