EXECUTIVE SUMMARY

Piggyback Recommendation of \$500,000 or Greater 56-022E – Commercial Copy Machines

The School Board of Broward County, Florida, (SBBC) and its Printing Services department are seeking to enhance printing services throughout the District by increasing the ability to complete regular routine printing projects. This request is to approve agreement 56-022E – Commercial Copier Machines to Konica Minolta Business Solutions U.S.A., Inc. This purchase is being made according to SBBC Purchasing Policy 3320, Part II, Section M, which says the following, "The School Board of Broward County Florida, School Board Policy 3320, Part II, Section M, permits the District to piggyback on contracts awarded by other city or county governmental agencies."

The estimated agreement amount will be \$853,728 with a ten (10) percent contingencies for a grand total of \$939,100. When new commercial copy machines are installed, annual revenues are forecasted to increase at a minimum of twenty (20) percent.

This agreement will provide commercial, high-volume copy machines, both black and white, and color that will be used in the District's Printing Services department. SBBC will access 56-022E - Commercial Copier Machines through the National Association State Procurement Officials piggyback contract through the State of Florida. This agreement will replace the need to access the State of Florida contract 55-048E-Multifunction Copiers, Service, and Supplies for the following copiers.
