**TITLE:**  
Agreement with the Broward Cultural Council for the Cultural Incentive Program Supporting Arts Education

**REQUESTED ACTION:**  
Approve the Broward Cultural Council's Cultural Incentive Program Agreement.

**SUMMARY EXPLANATION AND BACKGROUND:**

The School Board of Broward County, Florida (SBBC) and the Broward Cultural Council have continued to partner for more than fifteen (15) years to provide high-quality arts education programming through a continuation Cultural Incentive Block Grant. This grant is a matching grant between SBBC and the Broward Cultural Council. The Broward Cultural Council will provide \$15,000 annually for a two (2) year period, for a total of \$30,000 beginning October 1, 2016 - September 30, 2018. SBBC will match the funds provided by the Broward Cultural Council.

See Supporting Docs for continuation of Summary Explanation and Background. This agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel. This agreement will be executed by Broward County Government after School Board Approval.

**FINANCIAL IMPACT:**

This is a two (2) year commitment with a financial impact of \$15,000 annually for a total of \$30,000 over the length of the agreement. Adding these funds to the Innovative Programs Design/Support Department within the Portfolio Services Division will increase the Instructional Activities and Instructional Staff Training appropriation.
