**GENERAL OVERVIEW:**

This item is for Board approval of the Authorization to Advertise the Request for Qualifications (RFQ) for Professional Design Services for the design of the project; approval of the RFQ Form; and approval of the Professional Services Agreement Form, RFQ 17-102C. The RFQ is designed to have the Qualification Selection Evaluation Committee (“QSEC”) select the top ranked firm. Upon QSEC’s recommendation, a Board item shall be submitted to the Board with a recommendation to award the Design package to the successful Design firm.

The following project scope was approved in the September 7, 2016 Adopted District Educational Facilities Plan and in the District’s Capital Budget.

**Margate Middle School Total Funding Allocated for Project Scope Included is \$8,869,000 and Includes Soft Costs: Provide Professional Design Services for Margate Middle School**

Design Professional shall develop a complete set of design documents that can be permitted for construction along with construction contract administration services. The design documents scope for this project includes, but is not limited to, single point of entry, fire alarm, safety/security upgrade, fire sprinklers, conversion of existing space to music and/or art lab(s), art room renovation and equipment, electrical improvements, building envelope improvements, media center improvements, HVAC improvements, and other items that may be required to execute the Board approved scope.

A Design/Bid/Build delivery method is recommended for this project. This recommendation is based on project specific considerations that included budget, design, schedule and risk assessment.

Remaining Board approved SMART Program Scope:

Music equipment is being managed separately by the District Music and Performing Arts Department. Per the most recent Bond Oversight Committee quarterly report (data through 6-30-16) the Gap Analysis and Priority effort has begun 6/30/2016.

School Choice Enhancement is being managed separately by Heery International and is scheduled to start January 2017.

CAT 6 data port upgrade, wireless network upgrade, technology infrastructure upgrade, and additional computers to close computer gap, are being managed separately by the District’s Information & Technology Department. The following status was obtained from the Broward County Public School's website and reflects information as of 9/8/2016. Technology Infrastructure – Not Started; CAT6 Dataport – Not Started; Wireless Network – Not Started; Computer Gap - Not Started.
