SUMMARY EXPLANATION AND BACKGROUND:
Scope of work: Design Professional shall develop a complete set of design documents that can be permitted for construction; along with construction contract administration services. The design documents scope for this project includes, but is not limited to, single point of entry, safety/security upgrade, fire sprinklers, weight room renovations, HVAC improvements, electrical improvements, building envelope improvements, and other items that may be required to execute the Board approved scope.
