

WHEREAS, the Broward Reads campaign is a collaborative initiative between community stakeholders including the School Board of Broward County, Broward County, the Children's Services Council of Broward County, the United Way of Broward County, and the Early Learning Coalition of Broward County, among many other community partners; and

WHEREAS, the Broward Reads campaign focuses on four critical areas including school readiness, chronic absenteeism, family engagement, and preventing the summer learning loss to ensure Broward's children are reading at grade level; and


