SUMMARY EXPLANATION AND BACKGROUND:
The School Board of Broward County, Florida, received one (1) bid in response to ITB 18-052R. This Bid will be utilized mainly by Physical Plant Operations. This ITB will allow the District to find a more cost-effective and efficient method of replacing aging theater dimmer racks and stage lighting equipment that is often from the original installation when the school was built.
